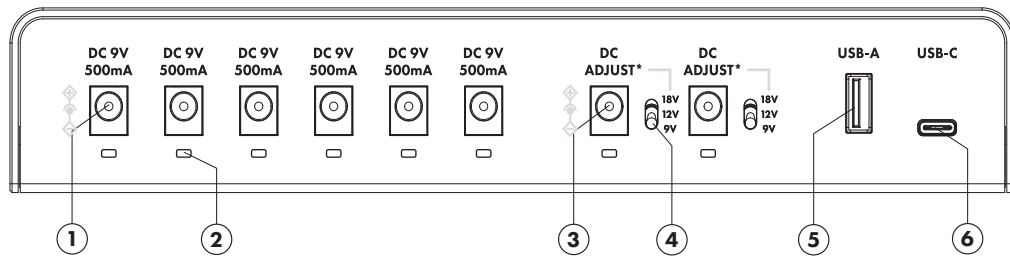

1. Ground Isolated Output (Fixed)

Six 9VDC at 500mA fixed isolated outputs.

2. Output Status LED

Two-color current output status LED. Green indicates current within specifications, red indicates current overload.

3. Selectable-Voltage Output

Two isolated outputs with selectable voltage (9V/12V/18V) using three-way toggle switch.

4. Selectable-Voltage Output Switch

Two three-way toggle switches; one for each selectable-voltage output (9V/12V/18V).

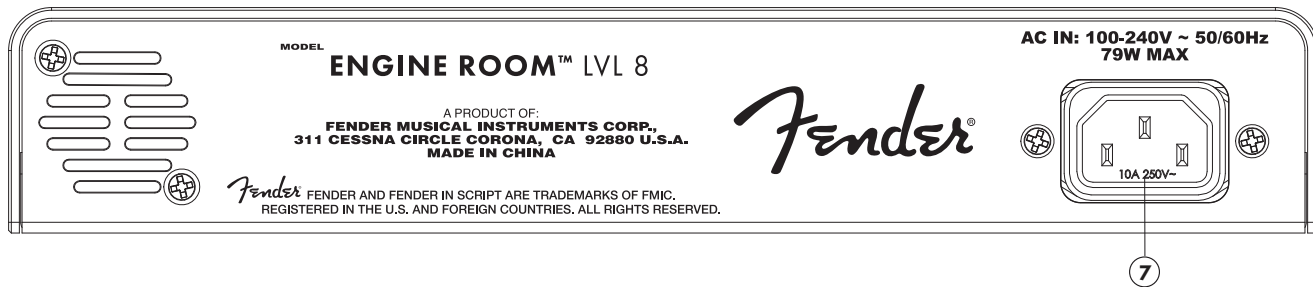
5. USB-A Output
